Determining the Phenotypic Interplay of Antimicrobial Bacteria Is Relevant for the Duration of Infection and Assessment of Antibacterial Therapy. Methicillin-resistant *Staphylococcus aureus* (MRSA) and vancomycin-resistant *Enterococcus* (VRE) are the most common bacteria causing nosocomial infections, prompting the search for effective agents. However, bacteria form bacterial microcolonies, and bacteria have been found to undergo phenotypic changes during persistent infection, especially in patients receiving antimicrobial therapy. These changes, even subtle, might alter the susceptibility to antimicrobials. The objective of this study was to describe the changes in the susceptibility of one MRSA and two VRE strains to antimicrobials, and to determine the duration of colonization. Two MRSA and two VRE strains were inoculated in broth and cystic fibrosis sputum medium, and the CFU of each strain was determined over a 10-day period. At day 10, the time points with the highest and lowest CFU numbers were selected. The time of selection was correlated with the minimum inhibitory concentration (MIC) of antimicrobials. Our results showed that the time of colonization correlated with the MIC in 8 out of 12 experiments. When evaluating the MICs of antimicrobial agents at the end of 10 days' duration of colonization and when monitoring the minimum duration of therapy to eradicate the pathogen, all obtained trends were therapeutic.
